## **Sales Tax Nexus**

- Nexus = "Connection to the State"
- Physical Nexus
  - Company Formation, Office, Employees
  - Stock/Inventory (Amazon FBA)
- Economic Nexus
  - June 2018 Wayfair vs. South Dakota
  - \$100K in Sales or 200 Transactions
- Marketplace Nexus
  - Marketplace Collects on Your Behalf (Amazon, Walmart)
    - NOT Shopify
- When Did You First Create Nexus?

# The Cost of Non-Compliance

- Florida Sales Tax
- What are the penalties?
- Willful Failure to Collect Tax
- Pay 100% of uncollected tax
- 8.5% Average Sales Tax Rate = \$3500 in sales =\$300 + Owed
- 3rd Degree Felony
- \$300 or more but less than \$20,000
- Punishable up to 5 years in prison
  - Fine up to \$5,000

## **Behind on Sales Tax**

- Very common for new sellers
- How do you get on track?
- Determine which states you had nexus and when
- Conduct a Sales Tax Nexus Analysis
- Determines when you first had nexus
- Per state requires breakdown sales per state and per month
- Results are as follows:
  - Which states to register, and
  - Which states not to register, and
  - If registered which states to close out
- Sales Tax Nexus Analysis average cost is \$1,000.00

# How do You Pay?

- Determined you owe \$100 in sales tax to a state
- You Can't Just Sent in a Check
- First, Get Registered (Sales Tax Permit)
- File Past Returns and Pay Tax Due + Penalties, and Interest
- Your Not Finished...
- File final state sales tax returns.


### **Standard Operating Procedure Amazon Sales Reports**

### Sales Tax Nexus Analysis & Results

Based on your submitted sales report data provided, the table below shows your total sales in each state and your estimated number of transactions in each respective state. We also considered the states where you had physical nexus (which includes home state and FBA states with stock).

#### Below is a summary of the states in the following categories:

- Registration Required: States with Prior Nexus and a Sales Tax Liability. This could
  be either physical, economic nexus, or notice and reporting states. Nexus in these states
  will result in past sales tax liability, penalties, interest, and past returns due. We will also
  provide you with effective dates, which means the dates you first had nexus in the state.
  The effective date is when your responsibility began for past sales tax, penalties, and
  interest before you registered and started collecting or the state began collecting on your
  behalf (see marketplace nexus states).
- Registration Required: Marketplace Nexus States. This applies even if you had no prior nexus in the state. Marketplace nexus means you started selling after Amazon was already collecting and remitting sales tax. You are required to register and file sales tax returns.
- States to Stay Registered. These are states where, once you are registered, they
  require you to stay registered and file returns, even if the marketplace facilitator (i.e.,
  Amazon, Walmart) is collecting and remitting.

#### 1. Registration Required: States with Prior Nexus and a Sales Tax

**Liability.** Both Physical and Economic Nexus, before Marketplace collecting, results in owing past sales tax, penalties, and interest.

#### Physical Nexus (Amazon FBA)\*:

27 Possible Key States: AZ, CA, CO, CT, FL, GA, IL, IN, KS, KY, MD, MA, MI, MN, NV, NJ, NC, OH, OK, PA, SC, TN, TX, UT, VA, WA, WI

**5 FBA states where registration is NOT required:** 1: NY is the only state that has an exception where an out-of-state seller with FBA stock is not required to register. 2: Alabama is a sorting center only and does not create nexus 3. Delaware, New Hampshire, and Oregon are FBA states, but there is no sales tax.

Here are the FBA states where you need to register before *creating either economic or marketplace nexus in the states*.

Other Physical Nexus. An example of another type of physical nexus, which would include an LLC in your Home State that is not already an FBA state or covered by an earlier economic nexus date.
