[Caution] 27 States will Mail Your Permit, PIN, or Code to Complete Your Tax Account

There are 27 states that will **mail either the sales tax permit, PIN, and or a code** to your address on file as part of the application process. When you use our [virtual address service](#), all that mail will come to our office and be scanned.

States that issues permit online but also mail permits (These are mostly the states that create a tax account first prior to registering for permits). You will have your account set up online and your permit. Your permit will also be mailed to you on letterhead from the state. We do recommend you have that organized in an online file folder per state, in case a state or marketplace requests proof of your registration.

ARIZONA - a temporary password will be sent to the email for verification. Email address cannot be changed so prefer to use the client's email

GEORGIA - permit numbers are sent via email. Has authentication code prior to the first login which will be sent via email as well

HAWAII - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email.

KANSAS - permit numbers are also issued via mail. The state has no authentication code prior to the first login

KENTUCKY - has an email verification process prior to the permit registration. Email address can be changed but it is a tedious process so prefer to use the client's email

LOUISIANA - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email

MASSACHUSETTS - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email

MICHIGAN - permit numbers are also sent via mail. Confirmation codes are sent via email in linking business and sales tax registration to the account, but email can be changed.

MINNESOTA - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email.

NEVADA - permit number is also sent via mail. No authentication codes prior to the first login.

NORTH CAROLINA - permit number is also sent via email. No need to set up a tax account. In filing return, the permit number is only needed

OHIO - permit numbers are issued online. No authentication codes prior to the first login

SOUTH CAROLINA - permit numbers are also mailed. The temporary password will be sent via email after the permit is issued.

TEXAS - permit numbers are issued online. WebFile numbers are issued via mail. WebFile numbers are only used to file returns (not part of our process)

VERMONT - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email

VIRGINIA - permit numbers will be issued online. Setting up tax account is not tedious since no email verification is required

WASHINGTON - UBI/permit number will also be mailed. No authentication code needed on the first login

WEST VIRGINIA - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email

WISCONSIN - permit numbers are also sent via mail. Has authentication code prior to the first login which will be sent via email

Total - 19 states

(keep in mind as the states change their process this list will change over time).
